Dear Bird and Pet enthusiast

The impact of fireworks on aviary kept birds and other pets

The New Zealand Finch Breeders Association Inc. (NZFBA) holds concerns for the welfare and on-going viability of finch species held in New Zealand. Several species bred by NZFBA members are considered threatened locally, as well as internationally. With this in mind, the NZFBA wishes to maximise the chances that finch species breed and sustain populations within New Zealand aviaries. Several NZFBA members have observed that the use of fireworks is detrimental to the on-going viability of aviary kept birds held in New Zealand. Similar concerns are held for the welfare of other pets or livestock, although the status of various finch species may be more fragile. The NZFBA decided to raise this issue with a Government Minister to assess whether further restrictions could be considered. The NZFBA is interested in your view. In our view, the current restrictions on fireworks are insufficient to remove the risk to aviary kept birds or other pets/livestock. The Minister's reply suggests that the situation will be monitored, but there is no explanation as to how this might be achieved on an objective and informed basis. Apart from monitoring the sale and use of fireworks, bird and pet interests could usefully tabulate and/or quantify the impact that fireworks have on their members' interests. Could you please consider this issue within your interest group or club, and provide a reply outlining your views to the NZFBA by **30 June 2011**. Following that, the NZFBA may look to write to the Minister for the Environment to further outline some of the concerns and suggested approaches to better address our issue in the medium term. It would be good if several other bird clubs or pet enthusiast organisations could support the concerns held, such that the Minister and department officials could see the wider level of support for action.
